### Summary of Consultancy Role

AVPA seeks to recruit a **Project Manager** for a two-year term. The Project Manager for AVPA's 'Knowledge Centre & Capacity Building Project' (KC&CB), financed by the African Development Bank (AfDB) through the Fund for Africa Private Sector Assistance ("FAPA") - Project ID No:P-Z1-KB0-018, will be responsible for building credible Knowledge Center offerings and developing robust capacity building programs with a view to enhancing the readiness of social impact investors to achieve their aspirations for social impact by helping them better understand new investment approaches.

### Main Expected Outcome Of The Project

Increased capacity and effectiveness of social investors to improve access to funding for social entrepreneurs.

### Key Responsibilities

- Ensure compliance with grant requirements while maximizing the use of funds through effective budgetary planning, control, reporting and approvals.
- Plan, generate and disseminate practical studies, market analyses and investment reports that outline and detail the funding and investment landscape across Africa with the various AVPA stakeholders.
- Generate practical insights and case studies relating to critical aspects in the funding and investment landscape of SMSEs on the continent.
- Develop a database of tools and resources (knowledge materials) that AVPA's constituents/members can use during and after the project.
- Create and deliver training offerings for new and advanced investors to help them engage in successful social impact investment.
- Leverage data and networks to implement an interactive online "Deal Share Platform (DSP)" that members can access to identify potential funding partners
- Provide management, technical oversight, and capacity building for CLA and MEL throughout the project cycle to ensure design and implementation are in line with AfDB policies, procedures and guidelines.
- Lead the design and implementation of the project's Collaboration, Learning, and Adaptation (CLA) framework, including the Monitoring, Evaluation, and Learning (MEL) Plan.
- Facilitate regular reviews, testing, and refinement of the project's logical framework and theory of change to ensure that learnings are incorporated into project planning and implementation.
- Organize periodic external knowledge exchange, learning and reflection events designed to improve the capacity and effectiveness of social investors to increase access to funding by social entrepreneurs.
- Manage, supervise and mentor the Assistant Project Manager as well as external evaluators or research partners so as to ensure a high-quality KC&CB project.

### Required Skills and Abilities

- Knowledge of contemporary means for knowledge sharing e.g. web tools and e-learning.
- Strong analytical and problem-solving skills.
- Strong written, verbal and presentation communication skills.

### Preferred Qualifications

- Experience implementing and managing CLA and MEL systems within organizations like: USAID, AfDB and/or DFID (now FCDO)
- Proven ability to use data collection, analysis, and visualization software (e.g., Commcare, ODK, SPSS, STATA, Zoho reports, PowerBi).
- Strong quantitative and qualitative data analysis experience.
- Demonstrated experience in generating communication and learning products such as publications, case studies, reports and learning briefs.
- Demonstrated experience organizing learning events for diverse audiences.
- Experience in building the capacity of partner organizations, key stakeholders and staff on CLA.

- Master's Degree in a relevant discipline such as International Development, Knowledge Management, Organizational and Adult Learning.
- At least six years of experience implementing learning, monitoring and/or evaluation activities for complex programs across Africa.
- Experience in establishing, maintaining, and using MEL systems (including developing theories of change, results frameworks, logic models, MEL plans, learning and accountability plans).
- Experience in facilitating meetings and events with a wide range of stakeholders (internal and external) that result in collaborative decision-making and agreed upon priorities.
- Experience using MS Windows and MS Office packages (Excel, Word, PowerPoint, Outlook), web conferencing applications, and information management systems.
